### Heartbeat Bendigo

#### Aims

- To offer support to patients and their family and friends following a cardiac event such as heart attack, heart surgery, stents, angina, etc.
- To assist in the development of local cardiac units by raising funds for the purchase of additional equipment.
- To promote friendship through meetings and social events.

#### Our history

Our very first meeting was a public meeting held at the Bendigo Hospital on the 30th of November 1986 and was attended by 32 people (some of whom are still members today). At that meeting it was decided to form a branch of Heartbeat Victoria in Bendigo. Thus, a committee was duly elected. The Bendigo Branch was therefore formed just 2 years after the first Melbourne Branch and 6 years after the foundation branch of Heartbeat was formed in Adelaide in 1980.

#### Heartbeat Bendigo today

Heartbeat Bendigo has approximately 75 members and holds meetings and many social activities, giving members the opportunity to be amongst people with similar health problems.

General Meetings are held primarily bi-monthly at 2.00pm in the Uniting Church Hall, Golden Square, followed by a cuppa and friendly chat. A dedicated Social Committee also organises a wide range of social events and members are kept informed and connected through bimonthly publication of the group's newsletter 'Tickertalk'.

Heartbeat Bendigo continues to support local cardiac services based at the Bendigo Hospital, St John of God Hospital, Dhelkaya Health (previously Castlemaine Health and Maldon Hospital) and Inglewood and Districts Health Services. It has now raised and donated more than \$400,000 to hospitals in the Bendigo region.

Whilst the emphasis is placed on the patients with cardiac problems, it is equally important to ensure that the partners and families of patients are not overlooked, as they also go through a very stressful time during a patient's recuperation.



## 2023/2024 highlights

Although we are still not able to access the local hospitals and cardiac rehabilitation programs in the same way as pre-Covid, the Branch's meetings, social events and fundraising efforts are continuing.

A new Social Committee has taken on the planning of the social program from the long serving and hard working previous Committee and members have enjoyed participating in a comprehensive calendar of social events including coffee catch ups, seasonal lunches, morning music concerts, bus trips, fashion events and trips to Melbourne for shows - and not forgetting the traditional Christmas in July and December Christmas events and the compulsory raffles at most events.

In order to ensure the affordability and viability of some of the social events previously offered, the Bendigo Domain Country Club has also invited Heartbeat members to join its residents on many of the outings that it arranges for the enjoyment of its residents.

Two major donations were approved during the year to Inglewood and Districts Health Service (\$11,500 for the purchase of a cardiac rehabilitation treadmill) and Dhelkaya Health in Castlemaine (\$14,500 for the purchase of three portable ECG machines for their three aged care facilities).

This year, Heartbeat Bendigo has also been generously supported by other local community groups in particular Country Music and Spring Gully Dance Club who have run special fundraising events in support of Heartbeat Bendigo. Heartbeat Bendigo was also thrilled to receive a \$4000 Federal Government grant for the next financial year.
